

CITIZENS POLICE ACADEMY PROGRAMS

What is the Citizens Police Academy (CPA)?

The CPA is an interactive program designed to educate the public about HPD policies, the criminal justice system, and ways to reduce crime. The CPA allows members of the department and citizens of the City and County of Honolulu to meet, share ideas and information, and interact in a positive and proactive setting.

What is the

Business Citizens Police Academy (BCPA)?

The BCPA is similar to the CPA with an emphasis on business-related topics.

How can I apply for the CPA or BCPA?

Please complete the application provided and mail or bring it to the Community Affairs Division, 801 South Beretania Street.

What type of information will be presented?

Sessions cover a variety of topics, including firearms, communications, report writing, police vehicles, domestic violence, crime scenes, and community policing.

How does the CPA improve police-community relations?

Many misconceptions, suspicions, and fears are caused by a lack of understanding of police responsibilities. Many of these problems can be addressed through education, closer contact with the public, and a better understanding of the work of police department personnel.

Who can attend?

Participants come from a cross section of our community. They include, business executives, government agency representatives, news media personnel, members of neighborhood boards, community groups and organizations, and the general public. Participants must be at least 18 years of age.

When and where?

CPA participants meet for three to four hours on a weeknight and two Saturdays over 11 weeks. The majority of the sessions are held at the Alapa'i headquarters. Other locations include the Ke Kula Maka'i, the HPD's training academy in Waipahu.

BUSINESS CITIZENS POLICE ACADEMY

What type of information will be presented?

Topics include business-related subjects such as credit card fraud, forgery and check fraud, identity theft and internet crimes, auto theft, crime prevention though environmental design, shoplifting and employee theft, and workplace violence.

Who attends?

The BCPA is made up of members from the private and public sectors. Participants must be at least 18 years of age and maintain a good standing in our community.

When and where?

Participants meet three to four hours a week for ten weeks. The sessions are held at the Honolulu Police Department's Alapa'i headquarters.
