FEES

The Police Activities League (PAL) <u>no longer charges any fees</u> for a child to participate in any of our activities. However, each individual team may require your child to pay a team registration fee to cover the team's expenses such as pictures, uniforms, banquet, trophies, etc. In that case, you should be able to obtain a complete and detailed breakdown of the team's funds expenditures from your child's coach.

Preamble

The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles: trustworthiness, respect, responsibility, fairness, caring and good citizenship. The highest potential of sports is achieved when competition reflects these "six pillars of character."

I therefore agree I will:

not force my child to participate.; remember that children participate to have fun and that the game is for youth, not adults; inform the coach of any physical disability or ailment that may affect the safety of others.; learn the rules of the game and the policies of the league.; ensure my guests and I will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.; ensure my guests and I will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing and taunting; refusing to shake.; or using profane language or gesture; not encourage any behaviors or practices that would endanger the health and well-being of the athletes.; teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.; demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.; teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of the game or his or her performance.; praise my child for competing fairly and trying hard and make my child feel like a winner every time.; never ridicule or yell at my child or other participant for making a mistake or losing a competition; emphasize skill development and practices and how they benefit my child over winning. I will also de-emphasize games and competition in the lower age groups.; promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win.; respect the officials and their authority during games and will never question, discuss or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place; demand a sports environment for my child that is free from drugs, tobacco and alcohol, and I will refrain from their use at all sports events; refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.

I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that could include, but is not limited to the following:

- Verbal warning by official, head coach, and/or head of league organization
- · Written warning
- Parental game suspension with written documentation of incident kept on file by organizations involved
- Game forfeit through the official or coach
- Parental season suspension
